Excessive Leave Balance – Succession Plan

This circular serves as a last reminder to all regarding the need to submit the above, as agreed and reiterated in a number of Secretaries Meetings, setting a deadline of end of May, to give PSO time to present its report, one month before the due date, which was June, to forfeit all employees' excessive leave balances over two years entitlements.

In response to our first circular on the above, and physical visits made to your respective offices, PSO received many submissions, if not all Ministries, that did not meet what was initially required – a succession plan on how those employees with excessive leave balances, intend to exhaust such leave days, within this year and subsequent years, so Government will not be obliged to pay terminal payment after retirement, while at the same time minimizing disruption of public service delivery.

To assist PSO in developing its report and submission to Cabinet on this issue, I have attached a SAMPLE template, modified from MISA's submission that will guide everyone in providing the details required of Government employees who have excessive leave balances only.

May I kindly request that your submissions are made before end of the month, otherwise Cabinet may decide not to overrule its earlier decision of forfeiting all excessive leave balances of Government employees.
